#### ASMS PA Raffle FAQ

Below are some tips concerning the raffle on Family Day. If you have additional questions, please post to the PA Facebook group or email <a href="mailto:asmsparents@gmail.com">asmsparents@gmail.com</a>. Thank you for participating!

#### Q: How do we make the checks out?

A: Checks can be made payable to ASMS Foundation with "PA raffle" in the memo line (memo line very important).

### Q: What if my friends/family want to pay electronically/online?

A: Friends and family have two electronic/online options:

- 1. They can pay you electronically via your preferred method, and you submit the money to the school via your preferred method when you turn in your completed form by the deadlines and methods listed on the form.
- 2. You or friends/family can email ASMS PA treasurer Stasia Dunlop at <a href="mailto:audunlop@gmail.com">audunlop@gmail.com</a> NO LATER THAN 10am, Thursday, October 11<sup>th</sup> for email instructions on funds transfer procedures to the ASMS Foundation. Entries will not be included in the drawing until funds are received.

### Q: Can I write one check for the total amount on my form?

A: Yes. You may collect all the cash, personal checks or electronic payments made payable to you directly and then submit one lump sum to the PA. When you turn in the form, either electronically transfer or submit one check (payable to ASMS Foundation with PA raffle in memo line) for the total amount collected, as calculated at the end of your form. It is up to you and your customers as to how you handle the money (following the instructions above). Only entries with collected monies will be entered in the drawing.

### Q: Is there an actual raffle ticket? What do I give friends/family after they pay?

A: Due to the logistics and cost of printing and distributing tickets to families of 270+ students across the state, we decided not to print actual tickets. Each \$20 paid is one "entry" into the raffle, and you may purchase more than one "entry." There is no physical ticket or receipt, much like school fundraisers for butter braids or cookie dough purchased in advance with names on a form. We suggest friends and family who purchase entry into the raffle take a cellphone picture of the top of the form so they have raffle details and the date of the drawing.

#### Q: Can students enter the raffle?

A: The name of the entrant listed on the form must be 19+ years old, a legal adult in the state of Alabama.

# Q: Can the winner transfer the prize to someone else?

A: Yes, the winner may transfer the prize to another legal adult.

## Q: Are there taxes and fees associated with winning this prize?

A: The ASMS PA has agreed to pay all associated taxes and fees. The overall value of the prize is \$1450, to include the condo and the \$25 gift cards to each of the four restaurants.

## Q: How many people can stay in the condo?

A: The condo has 3 bedrooms and 3 baths and sleeps 10.
